

RELEASE AND HOLD HARMLESS
Terrebonne 200 Parade and Festival

I, the Undersigned, and/or the children listed below (hereinafter, "Named Children") will be participating in and/or volunteering for the Terrebonne 200 Festival and/or Parade hosted by the Helio Foundation on Saturday, October 15, 2022, in conjunction with the Bicentennial Celebration of Terrebonne Parish (the "Event"). I acknowledge receipt of the Event staging instructions and map, Event regulations, and Event registration form. I have properly completed and delivered my registration form for participation and/or volunteering in this Event. I agree to abide by the regulations of the Event and in support of the Bicentennial Celebration of Terrebonne Parish, I will use, and I will require Named Children to use, good safety precautions during our participation or volunteer work. **I understand that any minors not named in this document are prohibited from participating in the parade and prohibited from volunteering in the Event; that minors under the age of 16 are prohibited from volunteering; and that volunteers must be 21 years old or older to volunteer in any station where alcohol is being served.** I am aware that by participating and/or volunteering, I and Named Children may be exposed to possible injury, including death, and that I and/or Named Children may suffer damage to our property. I do hereby assume full responsibility for our safety while participating and/or volunteering in the Event. I also assume full responsibility while in transit to and from the Event. I understand that I must provide liability insurance for any vehicle used in the Event and that neither the Helio Foundation or the Terrebonne Parish Consolidated Government nor any of their officers, agents, or employees will be liable for damage occurring to any vehicle used in the Event. I understand that should I or Named Children suffer any injuries, our Health Insurance Coverage shall cover payment for the treatment of those injuries as prime and only insurance. I expressly acknowledge that the activities of the Event (including, but not limited to, the pre- and post-parade activities and the set up/tear down of the festival) may be dangerous and may involve the risk of serious injury, death and/or property damage. **In consideration for my and/or Named Children's participation and/or volunteering in the Event, I agree to release and hold harmless the Helio Foundation, Terrebonne Parish Consolidated Government, and their elected officials, officers, directors, agents, employees, and contractors, including volunteers, from all liability arising from personal injury, including death, or property damage incurred by me and Named Children during the Event, during the staging of the Event, and during the disbanding of the Event. I further agree to protect, indemnify, and hold harmless the Helio Foundation, Terrebonne Parish Consolidated Government, and their elected officials, officers, directors, agents employees and contractors, including volunteers from and against any and all claims, losses, damages and expenses (including attorneys' fees and costs) for injury, illness or death, or damage to property arising out of my and Named Children's participation or volunteering in the Event or arising out of our negligence.** This agreement shall also serve as an acknowledgement of assumption of risk for me, Named Children, and our heirs, executors, administrators, successors, assigns, and for all members of my and Named Children's family. I am aware this Release and Hold Harmless shall be governed by and construed in accordance with the laws of the State of Louisiana. Any dispute arising hereunder shall be brought in the 32nd Judicial District Court in Terrebonne Parish, Louisiana. Any provision herein not enforceable shall be considered severed from this Release without nullifying it. **IN WITNESS WHEREOF**, I, the undersigned, have read the Release and Hold Harmless and agree to its terms and conditions and that I am authorized to sign this document on behalf of myself and the Named Children.
